

Seattle Colleges District Nursing Program | Nursing Assistant-Certified (NA-C) *Immunization Requirements*

Below are the immunization requirements for the Nursing Assistant-Certified (NA-C) Program at Seattle Central College. These immunizations are required by our site partners, where you will be completing the mandatory 40 hours of work for your clinical placement in NURS 109. To be successfully onboarded at the clinical site, you will need to submit complete and accurate documentation of the immunizations listed below. Documentation requirements:

All documents must be first-source documents, meaning they originate from the health care provider responsible for ordering and/or administering the immunization, titer, or test.

Note that immunization summaries—like those from MyChart, MyIRmobile, or similar—may not include all required information, so you may need the clinic to stamp identifying information on your documentation or provide written comment from the health care provider with supplemental information.

A Certificate of Immunization Status (CIS) from the Washington State Department of Health will satisfy requirements for Flu, Tdap, MMR, and Varicella.

First-source documentation in a non-English language will need to be translated.

All documentation must include:

- Applicant name
- Applicant date of birth
- Clinic name (ex. CVS, NeighborCare Health, UW Medicine, labcorp, etc.)
- Clinic contact information (ex. address, phone number, etc.)
- Provider name and credentials
- Date(s) of service

Vaccinations should show the vaccine lot number, expiration date, and site administered

Lab results *must* contain values, reference ranges, and interpretation of results (positive/negative, immune/non-immune, reactive/non-reactive)

Tests, such as the two-step Tuberculin skin test, must include all dates of service

Immunization requirements:

- Flu
 - Documentation with proof of vaccination in current vaccine season
 - Flu seasons start in August/September and end in May/June
- Covid
 - Documentation with proof of vaccination in current vaccine season
 - Manufacturer (ex. Moderna, Pfizer, etc.) is required
- Tdap (Tetanus)
 - Documentation with proof of vaccination within the last 10 years
 - Vaccination cannot expire/lapse amid duration of enrolled quarter
- MMR (Measles, Mumps, Rubella)
 - Documentation with proof of two-shot vaccination series
 - or**
 - Documentation with proof of positive titer for *each* component of MMR
 - If the result of your titer is negative, you will need a booster shot
- Varicella (Chicken Pox)
 - Documentation with proof of two-shot vaccination series
 - or**
 - Documentation with proof of positive titer
 - If the result of your titer is negative, you will need a booster shot
- Tuberculosis
 - Documentation with proof of negative two-step Tuberculin Skin Test (TST) within the last year
 - or**
 - Documentation with proof of negative QuantiFERON IGRA blood draw within the last year
 - If you test positive with either the two-step TST or the QuantiFERON IGRA, you will need to provide a chest x-ray and complete a symptom check form (form provided by our office)
- Hepatitis B
 - Documentation with proof of positive titer
 - *You will only receive a positive titer if you have been previously immunized to Hepatitis B*
 - If you have previously completed an immunization series but get a negative titer, you will need to restart the series and re-titer
 - You *may* start the program if you have not completed the Hepatitis B immunization series; however, you will need proof of your first dose to show that your second series is in progress



Immunization resources:

If you are missing any of the requirements from the above list and would like resources on accessible healthcare providers for a vaccination, test, titer, or physical exam, please explore the list of providers below, located in and around the Seattle area.

If you are not from Seattle or Washington and have a provider in a different city, state, or country, you can have your immunizations administered there, as long as you provide the required documentation. Immunization records from outside of the United States will need to be translated to English if from a non-English speaking country.

Your primary care provider—can provide vaccinations, tests, titers, and physical exam

Please be aware that we do require documentation of applicants' health insurance information. If you do not currently have health insurance, explore coverage options on [Washington Healthplanfinder](#).

Community health centers—can provide vaccinations, tests, titers, and physical exam depending on the clinic and their services

These clinics offer cost assistance/sliding-scale fees, accept Medicaid insurance coverage, and treat uninsured patients.
