

Q & A for the Dental Hygiene Applicant

Here are some answers to the most common questions:

Q: The application deadline is in December. I'm close to having the number of science and non-science courses to be able to apply. However, in winter quarter, I will still be taking the last of the prerequisite courses required to be eligible to apply. Will I still be able to apply?

A: Unfortunately, this disqualifies an applicant. All prerequisite courses must be completed *by the application deadline of the year you intend to apply.*

Q: I would like to know more about the process of applying and I am a bit hesitant to create a profile in the online application system. How can I get information on how to apply and what the requirements are before I begin an online application?

- Go to the drop down "Programs"

Then, apply to Seattle Central College and schedule an appointment with an advisor at AdvisorCentral@seattlecolleges.edu. Once the advising appointment has been completed and they have ensured all prerequisites have been met, go to the Seattle Central College website and follow the steps below:

Q. Is there someone I can send my unofficial transcripts to so they can be evaluated. I need to make sure I'm completely on track rather than just thinking I am on track?

A: Schedule an appointment with a Seattle Central College advisor on the main campus to create an educational plan.

Q. Can I meet with someone in the dental hygiene program to review the application process and have them help me?

A: Due to the number of applicants, we do not have the resources to provide a one-on-one session with all applicants. Seattle Central provides a great support system for all students. Your best resource for assistance and advising on the application requirements is to make an appointment with an advisor and can be completed via this link <https://seattlecentral.edu/campus-life/student-support-and-services/advising/meet-with-an-advisor>.

Q. How do I get my official transcripts evaluated?

A: Apply to the Seattle Central College and complete the matriculation process. Submit official transcripts along with the form found online at <https://seattlecentral.edu/pdf-library/registration/workforce-evaluation-form-b-191.pdf>.

Q. Does Seattle Central Dental Hygiene program require the Test of Essential Academic Skills (TEAS)

A: Seattle Central College gives TEAS version 6.0

- The TEAS is a 170-question, multiple-choice computerized exam across four subject areas:

Reading:	58 minutes/48 questions
Mathematics	51 minutes/34 questions
Science	66 minutes/54 questions
English/Language Usage	34 minutes/34 questions

The entire testing process takes about 4 hours

- Official test scores. All exam scores must be sent directly from the testing agency to Seattle Central's Testing Center. Score reports provided to the applicant (i.e. examinees' copies, student copies, etc.) or photocopies of score reports will not be accepted.

Q. I have a B.S. in Biology, however I have not taken the prerequisite courses microbiology or anatomy and physiology. Do I have to take these courses before being eligible for the program?

A: All prerequisite courses are required and successfully completed with at a minimum grade of 2.5 for each course respectively. This grade requirement is not an overall GPA.

Q. Is it necessary to complete the associate's degree if I already have a bachelor's degree?

A: Yes. The entire program curriculum is required. The prerequisites and the eight (8) quarters of the dental hygiene program are required.

Q: How long is your program? How many credits for the entire program?

A: The dental hygiene program is eight (8) quarters. Program entrance begins summer quarter and runs through June of the 2nd year. The dental hygiene program Bachelor of Applied Science in Allied Health – Dental Hygiene consists of 195 credits including prerequisites.

Q. I want some guidance because I know this program is very competitive? Can you recommend classes I should retake?

A: We do not make any recommendations. Students must determine what is best for them. Just know the calculations will be based on the GPA of the most recent course. Also, be aware the state allows a maximum of 3 retakes for a course.

Q. Can I retake the essay?


A: No, essays can only be taken once during an application period.

Q: In the online application, I entered a course for the Humanities elective course requirement. When and how will I know the course I entered will be approved for this pre-requisite course?

A: It is recommended all prerequisite courses and transferred courses be reviewed with an advisor and course evaluator to ensure they will be accepted by the college.

Note in the graphic below: The green circle with the check mark indicates that the course is accepted. The blue circle with the "A" indicates this course must be reviewed by the Review Committee.

Q. How do I pay the application fee?

A: Once the application is complete and the submit button is clicked, the next step is the application fee payment and is prompted electronically. There is a choice to pay online or print the form and take it to the cashier's office on the main campus. It is strongly recommended the application fee be paid online so the receipt is included as part of the application packet.

Q. I want to know more about the points used to calculate the application process.

A: Dental Hygiene student selection is calculated by completing the application criteria. The application and supporting documents comprise 50% of the total points for acceptance. The criteria for the available 20 points are listed in the following table.

The second portion of the selection process consists of a group interview. The mandatory interview will contribute 50% to the final calculated application score.

Q. The recommendation letter and the community service, how do I submit them? Should it be in an envelope and by hand?

A: Letters of recommendations need to be submitted by email directly from the recommender. Letter must be emailed to Nancy.Harris@seattlecolleges.edu and should come from the supervisor only. The

Community Service Verification and Recommendation form is to be completed by the community service supervisor

Q. Who should the professional letter come from?

A: **Acceptable** Professional References: Previous supervisor, former or current instructors, or any organization where someone has been privy to your abilities.

Not acceptable: Neighbors, current/previous co-workers, family members, someone you babysat for, association/club officers, etc.

Q. I'm wondering how to record my volunteer/community service hours. How should I document my hours?

A: Each applicant will create their own log to record the community service hours. For each time you volunteer make sure you have your supervisor sign the log. The supervisor will also need to verify the number of hours volunteered with their organization. Only hours completed in the last five (5) years will be accepted. The supervisor needs email the Community Service Verification and Recommendation form to Ms. Harris at Nancy.Harris@seattlecolleges.edu

Q. If I was an alternate from the previous year, are spots held for the top three (3) alternates?

A: No, this is not an option.

Q. I bombed my interview, can I reschedule another interview?

A: No, there is not an option for a second interview. Coordination of applicants, staff, facility, and the interview team is cumbersome as well as time consuming. The acceptance deadline needs to be adhered to and does not allow sufficient time for all applicants to have a second interview.

After Acceptance

Q. Is there a background check process?

A: All accepted students must complete a National background check. The information will be sent to the student once accepted into the program. Students must have a clear background without any discrepancies to be able to enter the program.

Q. For the health history packet, can I meet with one doctor or do I have to meet with different doctors, i.e., primary physician, eye doctor, etc.?

A: Prior to entering the program, schedule a physical examination with a healthcare provider. Take the health history forms (the forms will need to be completed and signed by your healthcare provider).

Schedule a vision/eye examination with an optometrist and should include an evaluation of depth perception. Students will be required to wear safety glasses during all lab and clinical activities/procedures. Options for students needing prescription eyewear will be covered at the orientation meeting the last week in April.- Side shields are required on all safety glasses including

personal prescription glasses. Some frame designs create difficulty in meeting this requirement. A pair of non-prescription safety glasses is included in the summer instrument issue.

Q. What types of Immunizations and documentation are required?

A: The following immunization and document is required. (Lab results must be included):

- Hepatitis B requires the 3-dose series or positive titer showing immunity
 - Influenza requires a 1-dose given (during flu season September – June)
 - 2-step tuberculin test, or if TB test is positive, it is necessary to have a chest x-ray and a TB Assessment signed by a healthcare provider or a QuantiFERON®-TB Gold In-Tube test (GFT-GIT) showing no active TB (must be done before entering the program)
 - Measles, mumps, & rubella (MMR) requires a 2-dose series or a positive titer showing immunity
 - Varicella (chickenpox) requires a 2-dose series or a positive titer showing immunity
 - Tetanus, diphtheria, pertussis (Tdap) requires 1-dose within the last two years or TD within 10 years.
